SSIC ALSO PROVIDED NUTRITIONAL SUPPORT WITH 4,592 LIQUID NUTRITIONAL SUPPLEMENTS AND 317 FARMER'S MARKET VOUCHERS. HOT MEALS AND FROZEN MEALS WERE DELIVERED TO PARTICIPANTS' HOMES THREE TIMES A WEEK BY VOLUNTEERS.
